LIMITED WARRANTY

SCOPE: PRECISION TECH AERO, INC. warrants that each part that is either, "**OVERHAULED**", "**REPAIRED**" or "**FUNCTIONALLY TESTED/BENCH CHECKED**" shall be free from defects in material and workmanship for all work performed and parts installed at PRECISION TECH AERO, INC. for the period and under the conditions outlined below. Electrical part failures are not covered under any warranty. All warranty assessments and repairs must be performed by PRECISION TECH AERO, INC.

WARRANTY CLAIM POLICY: All warranty return claims must be received by PRECISION TECH AERO, INC. within ten (10) days of discovery and/or ten (10) days after the warranty expiration date, and must include date installed and removed, complete details of failure, time on unit, the PRECISION TECH AERO, INC. invoice number and the date purchased/received, otherwise the claim may be delayed or rejected. Labor required for removal, re-installation, or other related charges are the sole responsibility of the customer. PRECISION TECH AERO, INC. will not be responsible for transportation charges unless otherwise agreed.

WARRANTY LIABILITY LIMITATIONS FOR REPAIRS AND OVERHAULS: Mechanical & Electro-mechanical units "**OVERHAULED**" will be warranted for one (1) year from the day of shipment or one thousand (1000) hours of aircraft operations, whichever occurs first. "**REPAIRED**" units will be warranted for one hundred and eighty (180) days or five hundred (500) hours of aircraft operation, whichever occurs first. This warranty coverage applies only to components parts replaced and circuits and/or functions of the unit that was repaired. Cost of components, circuits and/or functions not repaired or replaced during initial repair will be the responsibility of the customer, including FOD affected components. "FUNCTIONALLY TESTED/ BENCH CHECKED" units will not be covered under any warranty.

WARRANTY LIMITATIONS AND EXCLUSIONS: Units returned to PRECISION TECH AERO, INC. for warranty that is found to be within manufactures specifications will be subject to re-certification charges.

PRECISION TECH AERO, INC. shall not be obligated if examination discloses that reported defects or malfunctions are due to improper storage/preservation, handling, installation, operation or general misuse. At any time warranty is only applicable to the actual portion of the components that were replaced or serviced by this facility, regardless of reported condition of components at the time of, or prior to any failure.

There are no expressed or implied or statutory warranties by PRECISION TECH AERO, INC. which extend beyond the description of the face hereof. Except for the provisions set forth above, there are no warranties of merchant abilities or otherwise. The extent of PRECISION TECH AERO, INC. liability under this warranty policy is limited to the repair of the "**REPAIRED**" or "**OVERHAULED**" units, and at our option, the repair or replacement of exchanged units. All others remedies against PRECISION TECH AERO, INC. for consequential or other damages arising out of a sale, use or operation of the accessory are excluded.
